For any violation, that could pose a health or safety concern, the Association maintains the right to forgo the two letter notice and send in a vendor to correct the violation immediately, if necessary. If multiple violations exist, the homeowner will be fined for each violation that exists independently of the others until each violation is corrected.

The Board of Directors has full direction for adjustment of violations and fine amounts.
